Sexual Harassment Prevention Training That Complies With California Law:

Carlton DiSante & Freudenberger LLP, a premier California employment law firm, has created an interactive training curriculum that is engaging, cost-effective, and fully compliant with the requirements of California Government Code Section 12950.1 (AB 1825). In general, this law requires all employers in California with 50 or more employees to provide at least two hours of sexual harassment prevention training to all supervisors in California every two years. Additionally, employers of this size must provide this training to newly hired or promoted supervisors in California within six months of the assumption of supervisory duties and then once every two years thereafter.

To assist employers in complying with the ongoing requirements of this law, we offer periodic training sessions at all five of our offices in California. (See reverse side for details of training sessions that will be offered in 2010.) We also recommend that employers with fewer than 50 employees consider having their supervisors attend this valuable training.
